## BIO

Summer Harlow, an associate professor of journalism in the Jack J. Valenti School of Communication at the University of Houston, has a Ph.D. in Journalism and a M.A. in Latin American Studies from the University of Texas at Austin. Summer, a trilingual (English, Spanish, and Portuguese) former journalist, researches the intersections of emerging media technologies, international journalism, alternative media, and activism, with an emphasis on Latin America and marginalized groups. She is the author of the award-winning *Liberation Technology in El Salvador: Re-appropriating Social Media Among Alternative Media Projects* (Palgrave-Macmillan, 2017), based on 12 months of ethnographic fieldwork in El Salvador as an Inter-American Foundation Grassroots Development Fellow. Previously she worked as an assistant professor at Florida State University. She has completed 11 book chapters and published more than 40 articles in Q1 peer-reviewed journals such as the *Journal of Communication*; *New Media & Society*; *International Journal of Press/Politics*; *Digital Journalism*; *Journalism & Mass Communication Quarterly*; and *Information, Communication & Society*. Her research has been cited more than 2,770 times (h-index 20, i-10 index 36).
